1.12.4.1 Value Stream Mapping - The contractor shall describe the current process by documenting the current activities, activities, and information flow. Existing documentation and information on the current process shall be used as much as possible. High level VSM and Final Time shall be performed and will last approximately 3-5 days. 1.12.4.6 Rapid Improvement Events (RIE) during execution week. The contractor shall perform rapid improvement events to reduce continuous improvement activities and principles into HMC Crane process (or) and shall demonstrate the ability to implement lean and six sigma approaches to enhance activity execution. These events will not be a planning session, but a planning and doing session. The goal of the event is to transfer knowledge and skills to HMC Crane employees while achieving significant improvement to cost, schedule and quality in the impacted areas.

1.12.4.7 There will be a 3-week preparation before an execution of a Rapid Improvement Event to include topics: team creation, and targets for the RIE. The contractor will be expected to actively participate in the preparation by contract team members, goals and approaches in order to enhance team results during the impending RIE week.

1.12.4.8 Rapid Improvement events will last normally 5 days although provisions should be made to accommodate any events by extension. The week is expected to proceed as follows: Day 1 will be devoted to fill customer needs. Day 2 will be devoted to study current conditions. Day 3 will be devoted to implement the plan. Day 4 will be devoted to the process. Day 5 will be devoted to develop of new process and develop it. Day 6 will be devoted to a standard, evaluation and implementation effort of activities. Day 7 will be lead team lead out of the process improvements that were made during the event.

1.12.4.9 The structure of the RIE week (5 days) shall include training, daily management briefing, support of the various RIE teams, evaluation of actual savings, doubling of the management team and final team presentation to management.

1.12.4.10 There will be a 3-week follow up on the improved process after the Rapid Improvement Event.

1.12.4.11 The following tools will be utilized for waste identification: Takt Time, Time Observation, MOC Chart, spaghetti Diagram, Combination Board, Standard Sheet, Production Control Board, Standard Kit.

1.12.4.12 The contractor shall identify to the Continuous Improvement One Year specific, achievable benefits and their associated metrics.

1.12.4.13 The contractor shall identify current and prevent the Continuous Improvement Team the before and after service.

1.12.4.14 The contractor shall develop implementation plans to assist with achievement of identified benefits.

1.12.4.15 The contractor shall establish baseline performance benchmarks utilizing lean, six sigma and Theory of Constraints prior to initiation of implementation activities.

1.12.4.16 The contractor shall analyze (following Continuous Improvement Implementation) performance improvements and develop a business case for similar implementation. These alignment review visits are expected to assess effective implementation.

1.12.4.17 The contractor shall provide personnel, qualified in the six sigma HMC approach as well as traditional lean manufacturing as requested by the customer. The contractor will provide training on essential tools and methods, project selection and project mapping to customer employees.

1.12.4.18 The contractor shall establish methodology for maintenance of the various Value Stream Maps, Rapid Improvement Action Plans, Training and coordination across multiple Value Stream Maps within the client site.
